1. Advise you of the relevant rules and procedure to follow.
2. Tell you which specified documents as per the immigration rules are required for your spouse visa.
3. Review all the documents to ensure that they meet the strict immigration rules requirements.
4. Complete your application forms.
5. Prepare your legal representations, as to how you meet the immigration rule as a spouse.
6. Prepare your application pack, which includes the legal representations, relevant application form and supporting specified documents.
7. Submitting the application pack to the relevant Home Office department in the UK.
8. Advise you on the outcome of the application and future steps, if applicable.

Disbursements are costs related to your matter that are payable to third parties, such as visa fees.

You will pay this to the Home Office directly as part of the application process.

You will be informed at the date of instruction the exact Government fees payable.

In-Time Spouse/Partner Extension Visa

The final price depends on your particular circumstances, such as:

1. Any complex immigration history.
2. Taking witness statements.
3. On what way your sponsor meet the financial requirement.
4. The amount of documents that we need to consider.
5. Whether you are applying with dependants.
6. Marriage interview by the Home Office to assess the genuineness of the relationship.

Key Stages and Timescales

Key Stage	Typical time line
